The Economic and Investment Plan identifies 10 investment flagships and aims to spur the long-term recovery, accelerate the green and digital transition, and foster regional cooperation.



Moving from plan to action: The EU has so far approved funding of €4.29 billion in grants, expected to mobilise €15.9 billion in overall investments. This includes funding of 54 flagship investments* under the Western Balkans Investment Framework with bilateral contributions from EU Member States and Norway, and favourable loans from international financing institutions.



Investments will only be sustainable if Western Balkan partners accelerate reforms, including in the area of rule of law and fight against corruption.
