### Title: Training and expert assistance to the Latvian Border Guard on border management procedures

# 1. Location

#### Ministry of Interior of the Republic of Latvia.

In the assistance will be provided to the:

- Central Board of Border Guard,
- Border Guard structure units dislocated on the Eastern border of Latvia (Ludza, Vilaka, Daugavpils Boards of Border Guard),
- Rezekne Border Guard training school.

# 2. **Project Objectives**

Wider objective of the project is to enhance the capabilities of the Latvian border Guard to carry out effective border supervision and control border crossing.

The main objective is to provide expert and training assistance in order to promote the establishment of border guarding in Latvia. To achieve main objective the following sub-objectives are identified:

- to upgrade the qualification of high-level and middle–level Latvian Border Guard officials in the field of Border management,
- to train the low-level Border Guard officials in securing of "green border", in the arrangement of border control procedures, in the organisation and management of border guard service, in the use of border protection control and technical surveillance systems,
- to train the communication specialists in the use and maintenance of modern radio, radio relay and telecommunication systems,
- to upgrade the qualification of service personnel of the Border Guard, Information system including the qualification of programmers and network administrators,
- to prepare the high level specialists of dog handler service,

The project objectives are suggested to be achieved through twinning with the Finnish Frontier Guard, in particular with the its training centre.

# 3. Description, project components & inputs

Project envisages to accomplish complex of arrangements in providing assistance in training of Border Guard of Latvia by the Finnish Frontier Guard. The project components are:

- Upgrading the qualification of high-level and middle-level Latvian Border Guard officials in the field of Border management by means of training courses mainly in Finland's training centres (1-2 weeks courses for groups of 4-5 persons three times per year)
- Training of chiefs of sub-units and other low-level border guards in securing of "green border" (1-2 week courses in the border guard school and practical training on the border, groups of 15-20 persons 5 times in each year and assistance in perfection of training means)
- Training in the arrangement of border control procedures ( document and persons control, control vehicles) in the use and maintenance of technical means, in the use of dosimetric control and drug search equipment (1-2 week courses in the border guard school and practical training on border control points)
- Training of the communication and upgrading the qualification of highest –level specialists in the use, maintenance and improving of modern radio, radio relay and telecommunication systems (training for 2-3 groups of 10-12 pers. per year, and assistance in perfection of training means)
- Upgrading the qualification of service personnel of Border Guard Electronic Information system of Border Guard including the qualification of programmers and network administrators (1 weeks courses for 4-5 pers. groups per year in and assistance in arrangement of computerised training class of Information centre of Central Board and organisation of training of computer specialists in Latvia
- Preparing the high level specialists of dog handler service and assistance in the special equipment and methodical material for training. (3 weeks program for 5-6 persons each year)

# **Expected results and outputs**

The result of the project is well trained personnel of the Latvian Border Guard to be able to organise the border guard services in Latvia in more effective and professional way according to Community requirements.

More specifically, the outputs of the project will be:

- 25-30 high- and middle level Latvian Border Guard officials are trained in the field of Border management,
- 400-500 low-level Border Guard officials are trained in securing of "green border", in the arrangement of border control procedures, in the organisation and management of border guard service, in the use of border protection control and technical surveillance systems,
- 50-60 communication specialists are trained in the use and maintenance of modern radio, radio relay and telecommunication systems,
- 25-30 computer specialists are trained in use, maintenance and servicing of Border Guard Electronic Information system,
- 20-25 high level specialists are prepared to carry out dog handler service

# 4. Institutional Framework

In the Republic of Latvia state's land border is guarded by State Border Guard – uniformed armed civil service under supervision of Ministry of Interior – the main task of which is to guard and control states border, to carry out the border control of persons and means of transport at road, railway, seaport and airport border control points, simplified border crossing points. State Border Guard consists of Central Board , 9 territorial Boards, Border Guard training school. The territorial Boards consists of border sections and border control.

There are 86 border crossing places determined on the state border:

16 road BCP (border control points),

12 railway BCP,

3 airport BCP,16 seaport BCP,39 border crossing points.

Fulfilling the tasks of protection of state border, State Border Guard co-operates with institutions of Ministry of Interior (Immigration police, State police, Department of citizenship and immigration) as well as Ministry of Foreign affairs and other states and local authorities.

Because the bilateral assistance of Finnish Frontier Guard's is in process, the implementation with the additional PHARE funds can be fit in to the ongoing training assistance by expanding both the length of the separate courses and increasing the number of the trainees as well as by arranging extra courses. More detailed protocols respecting the training co-operation for 1998 - 2001 will be signed by the heads of the services according to the basis of the requirements set out by the Latvian Border guard authorities in the bilateral negotiations that will take place twice a year.

# 9. Conditionality and Sequencing

- Develop human resource programmes to encourage personnel trained under this project to stay on their posts for some time in order for the Latvian administration to benefit from their acquired knowledge

- Ensure that Latvian trainers will be able to continue the training once the project has finished (trainthe-trainer)
- The project should be an integrated part in a long-term strategy for developing the Eastern border management in Latvia
