# COMMISSION DECISION (PH/2001/4053) Of 12 October 2001

Modifying Commission decision PH/98/3618 establishing a PHARE programme in Latvia,

- Sub-components LE9805.03.0003 'Rural Development Pilot Project' and LE98.05.03.0004 'Urban Development Pilot Project' included in the Component LE98.05.03 'Special Preparatory Programme for the Structural Funds'.

THE COMMISSION OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) N° 3906/89 of 18 December 1989 on economic aid to certain countries of Central and Eastern Europe <sup>1</sup>, as last amended by Regulation (EC) N° 2666/2000 <sup>2</sup>, and in particular Article 9 thereof.

#### Whereas:

- (1) Regulation N° 3906/89 lays down the rules and conditions for the granting of economic aid to certain countries of Central and Eastern Europe,
- (2) The National Programme for Latvia LE 98.03 LE98.09 was adopted by Commission Decision PH/98/3618 on 2/09/1998.
- (3) Specific circumstances have delayed the implementation of the programme and reasons of effectiveness warrant an extension of the duration of the programmes,

#### HAS DECIDED AS FOLLOWS:

### Article 1

The Commission Decision PH/98/3618 on sub-components LE9805.03.0003 'Rural Development Pilot Project' and LE98.05.03.0004 'Urban Development Pilot Project' of component LE98.05.03 'Special Preparatory Programme for the Structural Funds' is hereby modified as follows: The disbursement period concerning sub-component LE98.05.03.0003 (Rural Development Pilot Project) is hereby extended by six months until 30/04/2002 and concerning sub-component LE98.05.03.0004 (Urban Development Pilot Project) by eight months until 30/06/2002.
